OWNER: BAYSHORE REGIONAL SEWERAGE AUTHORITY

DESCRIPTION OF WORK: Furnish and Deliver Two (2) Four Inch Portable Diesel Trailer Mounted Sewerage Pumps.

EXAMINATION AND OBTAINING CONTRACT DOCUMENTS: Contract documents may be examined and obtained Monday through Friday, except legal holidays, from 9:00 a.m. to 4.00 p.m. prevailing time at the Bayshore Regional Sewerage Authority, located at 100 Oak Street, Union Beach NJ 07735. Contract documents may be obtained at a cost of \$25.00 per set. No refunds will be made.

BID SECURITY: Bid security is required in an amount of not less than ten percent (10%) of the total amount indicated in the bid, but not in excess of (twenty thousand dollars), whichever is the lesser, and shall be in the form of a certified check or bid bond.

CONSENT OF SURETY: A certificate from a Surety Company is required indicating consent to be bound as surety and guarantor for performance required under the contract documents.

Submission of Bids: The complete bid form and other items required shall be placed in a sealed envelope and delivered prior to the bid opening to the Owner at the above stated "ADDRESS FOR RECEIVING BIDS". The envelope will be clearly marked "BID #82-O FURNISH AND DELIVER Two (2) Four Inch Portable Diesel Trailer Mounted Sewerage Pump" and the date and time of the Bid Opening.
