# MINUTES FOR REGULAR MEETING MONDAY, APRIL 21, 2014

At 7:01 P.M. on Monday, April 21, 2014 Chairman Khachaturian called the meeting of the Bayshore Regional Sewerage Authority to order and makes the following announcement:

I hereby announce that pursuant to Section 5 of the Open Public Meetings Act, that adequate notice of this meeting has been sent to the Asbury Park Press and is on the BRSA Official Website. Notice has also been sent to the Clerks of Aberdeen, Hazlet, Holmdel, Keansburg, Keyport, Matawan, Union Beach and Marlboro and the Western Monmouth Utilities Authority. This notice is also posted in the lobby of the Bayshore Regional Sewerage Authority Administration Building.

Chairman Khachaturian asked all in attendance to stand for the Pledge of Allegiance and a Moment of Silence for the safety of US Troops all over the world.

Chairman Khachaturian requested a roll call of attendance:

### Reports

### BRSA Projects, Special Reports & Connection Applications

Mr. Fischer explained the most current graph which shows Hurricane Sandy expenditures and informed the Board of a FEMA payment in the amount of \$1.2 million dollars. He explained he submitted a request for an extension of time on all the projects however only the 3 large projects were approved. The other projects are pending and expected to be approved.

Mr. Fischer explained that we are still having problems with the Dorr Oliver Incinerator. The sand is "gluing" together. It is possible the heat is melting the ash and gluing the sand together. Chavond Barry is still checking it out and testing several possibilities to determine a solution.

Mr. Fischer informed the Commissioners he received over 20 applications for the Engineering Summer Intern Program. The list has been cut down to 6 and they will be interviewed and presented to the Board at May's meeting

Mr. Fischer explained the Odor/Corrosion Control Project at West Keansburg Pump Station. He would like to have 3 engineering firms from the short list submit proposals for the design.

#### Staff Engineer Report

Pete Canal reported the Matawan HVAC bid will be discussed in Closed Session. He explained that the Laurel Avenue subdivision – Country Side Developers purchased this project that was approved by the Commissioner in 2006. Mr. Terry Sherman would like to renew the approvals and he has submitted review and connection fees in full.

Chairman Khachaturian asked what Chavond Barry next step is in determining the Dorr Oliver Incinerator start-up. Pete said they were here today looking for reasons for hot spots in the incinerator. They are testing the sludge, sand, oil guns and fuel. Mr. Fischer advised the board that a solution will be found.

#### Consulting Engineer Report

Manuel Ponte reported that some emergency repair contracts are ready to be closed out. A preconstruction meeting for the Lab Building HVAC was held and the contractor seems very compliant with out requirements.

#### BRSA Superintendent's Report

Mike Broyles explained that a lot of time was spent on the start up and running of the Dorr Oliver Incinerator. He said we still had a 90% removal and that Plant #1 is moving forward. The DEP was here for their inspection and commented that getting Plant #1 on-line would be a big benefit. Mike reported that somehow an oil & grease test was missed last May. He said the DEP will send a Settlement Agreement but hasn't seen any paperwork yet.

Mike talked about the Pretreatment Audit which includes looking at files and is performed every 2 years. He said there was an issue with expired permits however applications for renewal were sent out. The industry has 180 days to return the application.

### **Executive Director's Report**

Mr. Fischer commented on the bid opening he attended for the Basic Generation Services. He said that 5 bids were received for the Plant and 6 bids for the Pump Stations.

Mr. Fischer described the Close-out of the old Trustee held accounts and the establishment of a new Authority held Reserve Account.

Chairman Khachaturian asked about the contamination test that was performed. Mr. Fischer reported that the first test indicated lower concentration than clean-up criteria hence no further testing is required. Reports have been sent into the DEP.

#### Attorney's Report

Jim Gorman said he would like to discuss Conti and the Matawan HVAC bid in Closed Session.

Chairman Khachaturian called for a MOTION to approve the Treasure's Report

WHEREAS, on May 15, 2006 the Bayshore Regional Sewerage Authority (BRSA) approved Resolution No. 48/06 to Daniel Rubano for a five (5) single-family home subdivision located on 644 and 646 Laurel Ave., also known as Block 52, Lots 7&9, in Holmdel, NJ, and

WHEREAS, the developer paid a connection fee of \$22,355, and

WHEREAS, the sanitary sewer approval issued by the BRSA was good for 1-year and has expired, and WHEREAS, the developer did not move the project forward, and

WHEREAS, the project was sold to a new developer, Country Side Developers, Inc. (CSD), and

WHEREAS, CSD has submitted a new application and has paid \$19,975, which is the difference in connection fees paid in 2006 to the current rate totaling \$42,330, and

WHEREAS, the project received all local approvals including sanitary sewer service, and

NOW THEREFORE BE IT RESOLVED, the Commissioners of the BRSA hereby approve Country Side Developers, Inc. application for Laurel Ave. subdivision, Block 52, Lots 7&9, Holmdel, NJ. The applicant is hereby notified that it must have or obtain a valid NJDEP Treatment Works Permit prior to proceeding.

WHEREAS, the building is serviced by a HVAC unit that is 18 years old, and

WHEREAS, the HVAC unit was damaged during Hurricane Sandy flooding on October 29, 2012 and is no longer functioning, and

WHEREAS, the BRSA approved Resolution No. 40/14 authorizing the staff and consulting engineer, R3m engineering, Inc. (R3M) to prepare specifications and advertise a Public Contract, and

WHEREAS, R3M prepared and advertised public contract documents for Matawan Pump Station HVAC Repairs, Contract No. 75-S, and

WHEREAS, eight (8) sealed bids were received and publically opened on April 16, 2014 at 10 am EST, from a low of \$134,000.00 to a high of \$374,444.00, and

WHEREAS, Performance Mechanical Corp. of Wall, NJ submitted the lowest bid of \$134,000.00 but failed to submit a financial statement, and

WHEREAS, failure to submit a financial statement cannot be pursuant to P&J Contractor vs. Township of Woodbridge 365 N.J. Super 164 (App. Div. 2004), and

WHEREAS, the second lowest bidder WHL Enterprises, Inc. submitted a bid of \$144,300.00 with a financial statement, and

WHEREAS, the BRSA staff, attorney and R3M have reviewed the bids and are recommending award to WHL Enterprises, Inc. in the amount of \$ 144,300.00, and

WHEREAS, funds are available for this purpose, and

NOW THEREFORE BE IT RESOLVED, the Commissioners of the BRSA hereby award the Contract to WHL Enterprises, Inc. of Metuchen, NJ in accordance with the terms and conditions of the Contract Documents, in the amount not to exceed \$144,300.00.

**BE IT FURTHER RESOLVED,** the Executive Director is hereby authorized to execute any necessary documents to award the Contract to WHL Enterprises, Inc. of Metuchen, NJ.

WHEREAS, the Bayshore Regional Sewerage Authority (BRSA) facility was severely damaged during Super Storm Sandy on October 29, 2012, and

WHEREAS, the Administration Building required extensive repairs as a result of Super Storm Sandy flooding damage, and

WHEREAS, in accordance with Local Public Contract Law, Contract 64-S, Administration Building Reconstruction was awarded to Shorelands Construction, Inc. on April 15, 2013 for a total price of \$476,330.00 by Resolution No. 79/13, and

WHEREAS, during the reconstruction work our construction management firm, R3m engineering identified additional repairs and credits necessary for the completion of the project, which netted a credit of <\$2,966.93> and

WHEREAS, R3m and BRSA staff have reviewed Change Order No.1 and find it to be fair and reasonable, and

**NOW THEREFORE BE IT RESOLVED** the Commissioners approve Final Quantities Change Order No.1 for Shorelands Construction Inc., in amount of <\$2,966.93>, decreasing the contract amount from \$476,330.00 to \$473,363.07.
