Mr. Fischer spoke about the advantage of having an Asset Management Plan in order to better forecast future Capital Budget spending and as an aide to maintaining control over the user rate in the long term. Now is the time to update the information with all the new equipment being put in because of Hurricane Sandy. BRSA currently has a good maintenance management plan on computer.

Mr. Fischer introduced Mr. Richard Bernhardt of John-Winston Engineers Consultants Inc. Mr. Bernhardt presented an Asset Management Program Plan to the Commissioners. He explained four (4) steps of his plan:

- 1. Review & Data Validate The Existing Asset Mgt. Software (MP-2)
- 2. Asset Mgt. Planning and Recommendation
- 3. Plant Equipment Condition and Risk Survey (including new Post-Sandy Equipment)
- 4. Asset Mgt. Strategy Development Identifying Capital & Maintenance Options

Mr. Bernhardt said the main plan would project future capital investment requirements. The Operation and Maintenance would be better served to know what would hurt you most if the equipment broke down.

Mr. Fischer said this plan would help identify areas we haven't focused on, looking at the risk profile, looking at probability of failure and consequence failure, all quality assets.

John Napolitano said upcoming Trust Loans may require Asset Management Plan be put in place. It's going to be part of the Permit and is currently in CSO Permits. Mr. Fischer said that an Asset Management Plan is a requirement in Phase II projects from the NJEIT.

Mr. Bernhardt said the project should to about 4 to 6 months based on our current information.

2016 BGS Electric Contract Award

• NJ Sewerage and Municipal Utility Authority Electrical Supply Aggregation -received bids on November 20, 2015 for effective date of May 2016. Five bids were received for the plant electric and five for the pump station electric. Plant electric bid is a 17% reduction and the pump station electric bid is a 15% reduction over current rates.

• Potential Change Orders-Contract 71S-Various Authority Buildings- FEMA wants to lump together all small Change Orders. Due to credits for shared trailer space, extra tile work and replacement of building doors the total Change Order is approx. \$78,000.

Superintendent's Report-by Mike Broyles

- Treatment Plant Performance flow remains unseasonably low even with the recent rain.
- Effluent Quality remains good at 95% removal for TSS and BOD.
- Lab Suspension- went to DEP with data for the settlement agreement. The DEP will not Fine us or suspend us and they will give us a third chance at the Proficiency Test. If we fail the third test we will pay a \$1,000 fine and be suspended for 6 months. Upon our investigation we found that we were using cheaper filter paper for the TSS test and the vacuum was set too high drawing solids through the paper. We have changed to better paper and reduced vacuum. The DEP was satisfied with our explanation so they are giving us another chance. We should get the test by next week.

WHEREAS, the firm of John-Winston Engineers has performed these services for many clients including wastewater treatment plants, and

WHEREAS, funds are available for this purpose.
