Executive Director Report, BRSA Projects, Special Reports & Connection Applications

• Toll Brothers Regency@ Holmdel-185 unit townhouses plus a clubhouse- and Toll NJ IX Reserve @ Holmdel-40 single family homes located at the Lucent site- seeking Connection and Developers Agreements. All the paperwork is in and the projects will be divided into Phases. Kevin Kernahan, Vice President of Toll Brothers Land Development and Andy Cohen of Kennedy Consultant explained the Project, and the phasing plus the Commissioners asked questions about the 2 projects. REPORTS

<u>Executive Directors Report, BRSA Projects, Special Reports & Connection Applications</u> <u>Robert C. Fischer reported</u>:

Disaster Recovery Update -

- To date the Superstorm Sandy related expense stands at \$11,878,247. A reimbursement request was submitted in the amount of \$116,923 for emergency protective measures including overtime for staff during the early phases of recovery.
- NIRO Project low bidder is Stone Hill Construction and We received the DEP and NJEIT approval for the award of the NIRO Project
- Final flood insurance claim for \$286,331 was submitted and will bring the final total to \$2.5 million.
- On 3-27-15 bids will be received for the Various Building and Pump Station Project
- On 3-6-14 we submitted the Power Distribution and Blower Building Projects to the NJEIT for funding
- As of October 1, 2014 any Trust money for Engineering is being regulated by the Federal Procurement Laws 40-U.S.C. 1101.

Process – Advertise on Authority web-site or papers a (RFQ) Request for Qualification Choose top 3 candidates internally – based on qualifications Pick highest qualified firm and negotiate a fair and reasonable cost. If you cannot negotiate a cost negotiations move to the next candidate.

Not following this procedure could cost us over \$200,000.

Commissioner McMullen asked if we always had an estimated cost before bids are opened. Mr. Fischer said yes. Commissioner McMullen asked how come they wouldn't want the cost to be competitive. John Napalitano stated that the Federal System has always been based on quality not cost. They want you to hire the best qualified.

- Financial Disclosure Statements-they will be on-line April 1st to April 30th. You must use your log-in & pin numbers from last year. Mr. Fischer said he has everyone's numbers but doesn't have any passwords.
- NJ Sustainable Energy Joint Meeting (NJSEM) Natural Gas held their most recent bid. The bid price came in lower than last year. Direct Energy won the bid at \$.4809 per term which is a 7.5% decrease over the current rate we are

paying at \$0.5201 per therm.

• A <u>Not to Exceed Resolution</u> is on the agenda for the professional contracts passed at last month's meeting. Any additional work

beyond the "Not To Exceed" amount will require Any additional work need approval from the Board.

Staff Engineer Report

Pete Canal reported:

- Two bids for Plant Generators Set Test and Inspection were received. The lowest bid was from Foley, Inc. for \$23,200.00
- Power Distribution System Project Contract #81S-needs approval to advertise for RFQ's for Design and Construction Management, using the federal guideline method explained by Mr. Fischer.
- Combined Blower Building Project (NJEIT-2015)-needs approval to advertise for RFQ's for the Design and Construction Management.

Commissioner Vella asked about the sludge hauling. Pete said there's a meeting tomorrow with consultants to discuss their evaluations and plan the next step. He anticipates re-starting the Dorr Oliver next month, fix the fuel guns, tweak the fuel oil system and make repairs on the glowing hot spots.

Pete Canal left the meeting at 7:47 PM.

Consulting Engineer Report

Manuel Ponte reported:

- Various Plant Building Project bids due March 27th, BRSA's next meeting is April 20th. Possibly special meeting to award contract
- Generator Repair Project-plan is to refurbish to extend life for 10 to 15 years. Manufacturer to perform a thorough inspection to list items needed to refurbish the generators.
- 1st Quarter Flow Report-nothing surprising. Numbers are very close to prior years.
- Lab/Office & Matawan HVAC Update WHL- making progress and working on a punch list and administrative paperwork.
- Pete said they are planning to give WHL a final date for completion in April. WHL submitted a payment voucher this month but it came in late. We will schedule a punch list inspection, identify actual damages and address at close-out.

Commissioner Khachaturian asked if we received the warrantees for the equipment. Pete said we have not received them yet. John Napolitano suggested a letter be written to WHL explaining why they didn't receive payment. Otherwise WHL could request interest. Manuel said he sent them such a letter.

Mike Broyles reported:

BRSA Superintendent's Report

- Plant Performance we received one of our process air blowers back from repair and ran it for 24 hours. Plant l was put back on line. Effluent quality getting better.
- Issue with the dumpsters freezing. Called around and got Spectraserv to haul liquid sludge approximately ¹/₂ million gallons.
- IPP draft renewal permit. No comments were received. Request a motion to prepare and issue a final permit effective April 1, 2015.

Vice-Chairman Pisano called for a <u>MOTION</u> to issue the New Jersey Turnpike IPP Permit effective April 1, 2015.

Mike Broyles informed the Board about the issue of Stony Brook being down a week and they could not receive any dewatered sludge from us. After calling around Spectraserv was able to accommodate the disposal but at a higher rate than we are paying Stony Brook. Everything is currently back to normal.

Mr. Fischer reported to the Board that he reached out to the Government section of Apple for the IPads. They quoted a less expensive package however training is not included. They will instruct two people who will then train others. A discussion took place and the outcome was to do a cost analysis on the purchase of the IPads vs. doing the package manually to determine how long it would take to recover the cost of purchase.

Vice-Chairman Pisano called for a MOTION to approve the Treasurer's Report.

RESOLUTION NO. (44/15) - To award Request for Quotation 2015-01 for the Generator Set Inspection and Load Testing at the Wastewater Treatment Plant to Foley, Incorporated in the amount of \$23,200.00

WHEREAS, the Bayshore Regional Sewerage Authority (BRSA) owns and operates three (3) emergency power generators at the treatment plant located at 100 Oak Street in Union Beach, which are essential to the health, safety and welfare of the staff, community and environment, and

WHEREAS, the emergency generators have operated during power failures since installation in 1996 and most recently for seven (7) straight days during Hurricane Sandy, and

WHEREAS, various repairs and maintenance are required to the generators and the BRSA staff desires to perform a full evaluation of the condition, reliability and repairs necessary to bring the emergency generators into peak performance and reliability status (the Generator Project), and

WHEREAS, as part of the project, it is necessary to test the generators under full load, and

WHEREAS, R3m Engineering, Inc. (R3m) of Old Bridge, NJ was awarded the design of the Generator Project on December 15, 2015 via Resolution No. 128/14, and

WHEREAS, the BRSA approved Resolution No. 33/15 authorizing the staff and consulting engineer, R3m Engineering, Inc. to prepare Request for Quotations (RFQ's) and advertise on BRSA web site to inspect and load test the Generators, and

WHEREAS, the RFQ was advertised on the BRSA web site for at least 10 calendar days and two quotes were received and publically opened on March 12, 2015 at 2:30 PM EST, ranging in price from a low of \$23,200.00 to a high of \$29,545.00; and

WHEREAS, Foley, Incorporate of Piscataway, NJ submitted the lowest responsible responsive quote of \$23,200.00, and

WHEREAS, the BRSA staff and consulting engineer have reviewed the quotes and are recommending award to Foley, Incorporated in the amount not to exceed \$23,200.00, and

WHEREAS, funds are available for this purpose, and

NOW THEREFORE BE IT RESOLVED, the Commissioners of the Bayshore Regional Sewerage Authority hereby award the project to Foley, Incorporated in accordance with the terms and conditions of the RFQ, in an amount not to exceed \$23,200.00.

WHEREAS, the Authority has contracted for the restoration of the Dorr Oliver incinerator and has completed restoration repairs to the incinerator and,

WHEREAS, the Authority has experienced operating difficulties with the repaired incinerator that has caused the incinerator to be shut down while corrective action takes place and,

WHEREAS, the Authority has secured a back-up sludge process and a back-up sludge

disposal site to handle the volume of sludge generated at the treatment plant and,

WHEREAS, on March 2, 2015, Stony Brook Regional Sewerage Authority, the a back-up sludge disposal site informed the Authority of the shut-down of their incinerator for repairs and,

WHEREAS, the Authority must remove sludge from the treatment plant without delay to avoid adverse impact to the treatment process, the receiving waters and the neighborhood and,

WHEREAS, these adverse conditions could threaten the health, safety and welfare of the environment and the neighboring community and,

WHEREAS, the Authority has solicited prices for the emergency disposal of sludge until the Authority incinerator or the Stony Brook incinerator are operating again and,

WHEREAS, funds are available for this purpose and

WHEREAS, Spectraserv of Kearney NJ offered a price of \$76 per yard of sludge delivered to their processing site in Kearny, NJ and,

NOW THEREFORE BE IT RESOLVED, the Commissioners of the Bayshore Regional Sewerage Authority award an emergency contract to Spectraserv of Kearny, NJ for the disposal of sludge from the Bayshore Regional Sewerage Authority at \$76 per yard until either the Authority incinerator or the Stony Brook incinerator is operating at capacity.

Commissioner Steiner asked how much BRSA paid before. Mr. Fischer said \$50 per yard.

WHEREAS, as a member of the NJSEM the Authority has realized a 20% savings on natural gas commodity pricing as compared to the spot market pricing for the time period March 2013 to March 2015, and

WHEREAS, the existing natural gas contract for the members of the NJSEM expires in March 2015 and the NJSEM has conducted a natural gas commodity bid for the term March 2015 to December 2016 and awarded the low bid to Direct Energy at a price of \$0.4809/therm, and

WHEREAS, the low bid price of \$0.48097/therm represents a reduction of the current rate of \$0.5201/therm NOW THEREFORE BE IT RESOLVED, the Commissioners of the Bayshore Regional Sewerage

Authority deem it in the best interest of the customers and members of the Authority to continue membership in the NJSEM and Authorize the Executive Director to execute all necessary documents related to the natural gas contract for the term March 2015 to December 2016 thereby securing a lower cost for natural gas for a 10 month time period.
