# MINUTES REGULAR MEETING MONDAY, AUGUST 24, 2015

At 7:03 P.M. on Monday, August 24, 2015 Chairman Sutton called the meeting of the Bayshore Regional Sewerage Authority to order and makes the following announcement:

I hereby announce that pursuant to Section 5 of the Open Public Meetings Act, that adequate notice of this meeting has been sent to the Asbury Park Press and is on the BRSA Official Website. Notice has also been sent to the Clerks of Aberdeen, Hazlet, Holmdel, Keansburg, Keyport, Matawan, Union Beach and Marlboro and the Western Monmouth Utilities Authority. This notice is also posted in the lobby of the Bayshore Regional Sewerage Authority Administration Building.

Chairman Sutton asked all in attendance to stand for the Pledge of Allegiance and a Moment of Silence for the safety of US Troops all over the world.

# Reports

#### Executive Director Report, BRSA Projects, Special Reports & Connection Applications

#### Mr. Fischer Reported:

• <u>Disaster Recovery Report</u> – to date \$14,118,917.74 has been paid for Superstorm Sandy related damage. July received reimbursement from NJOEM for \$130,540.61 for design of the Various Authority Buildings Project, and Pump Station Project. Requisition #2 was submitted to NJEIT for \$401,769.50. Of that amount \$337,411.90 was submitted for FEMA reimbursement and \$372.40 was for SAIL Loan Principal Forgiveness. This meeting Stone Hill submitted a payment application for \$562,005.50. Of that amount, \$162,827 is FEMA reimbursable, \$123,308.50 is Sandy SRF and \$275,870 is traditional SRF. Mr. Fischer reviewed slides explaining progress on Contracts 71-S, 73-S & 74-S. Stone Hill and Hazen &

Sawyer have worked out equipment alignment issues and the flood wall will start as soon as we can get the permit from Union Beach construction offices.

- Union Beach construction official Bob Burlew required the BRSA to obtain an opinion from DCA as to which entity (DCA or local offices) were responsible to inspect the incinerator project. The DCA made a determination that the inspection must be performed by Union Beach. Prior to this, Union Beach stated that the work had to be inspected by DCA. The DCA opinion was submitted to Mr. Burlew.
- A Capital Budget and Operating Budget amendment was submitted to DCA last month and recently approved.
- GovDeals.com the DCA allows municipalities/agencies to dispose unneeded equipment and materials that are no longer needed for public use. The Authority can take advantage of this on-line auction and dispose of old surplus in an "as is" condition. GovDeals.com is approved under State Contract. Mr. Fischer explained the procedure by which the on-line auction is held.

#### **Staff Engineers Report**:

#### **Pete Canal Reported:**

Earlier today the Engineering Committee had a conference call to discuss the following projects.

- Lab/Office Contract 72 and Matawan Pump Station Contract 75S close out the engineering portion of this project. Amendment for Contract 72 is \$10,246 and Contract 75S is \$8,488.
- The contractor was very slow to respond to the Engineer and the Authority requests to close-out the project resulting in additional time needed by the Engineer. The amendments include provisions to create as built drawings. Pete commented that the units are working and we are waiting for the as-built. Chairman Sutton requested the as-build and specs be put on discs for safe keeping.
- Contract 74-S for the design of the NIRO Incinerator Project by Hazen and Sawyer is being closed-out with a credit of \$16,347.17.
- Contract 60-S General Consulting Services Chavond Barry Incinerator Engineers. The firm of CBE provided engineering consulting assistance during the start-up of the refurnished Dorr Oliver Incinerator. The incinerator experienced numerous fluidization issues until the unit was finally placed back on line on April 22, 2015. CBE Consulting Engineering budget requires an amendment for the additional work needed to bring the system back to full steady state.
- Authorization to advertise bids for Phase I @ Jersey Avenue TV Inspection and Cleaning of the West Keansburg Force Main Gannett Fleming Engineers
- West Keansburg Pump Station put on hold until September
- Raritan Valley Pump Station authorization to advertise for bids to replace the Comminutors
- Contract 73-S PS&S approve amendment in the amount of \$24,900 for spec changes,

FEMA HMP amendments and revised cost estimates required to coordinate the HMP charges.

The repair of the 3 Emergency Generators are out for bid now and the Authority plans to award contract next month.

Mr. Fischer asked Pete Canal to explain the Diffuser replacement portion of the Combined Blower Building Project. Pete said Hazen Sawyer was awarded the design contract for the Combined Blower Building. During design meeting the Authority and Engineers discussed the need to examine whether the original air diffusers in the tanks should be replaced. Hazen and Sawyer expected to install 2 new turbo blowers as part of the design however replacing the diffusers could reduce that to only 1 turbo blower. The cost of each blower is approx. \$260,000. The new diffusers would be more energy efficient, the new system would save us as much as \$45,000 per year. This project is not FEMA reimbursable, however we would be addressing this project in the near future.

- Continuing coordination meetings with BRSA staff and contractors.
- Review shop drawings and working with NJOEM on the funding.
- Generator bids are out and expected to be awarded at the next meeting.
- Prepared the 3<sup>rd</sup> quarter Flow Report.

#### **Superintendents Report**

#### **Mike Broyles Reported:**

- Flow has been low very dry
- Effluent numbers in the single digit @ 98% removal
- Fuel usage on the incinerator is 119 gallons per dry ton
- No odor complaints for July
- Fluidizing air blower shortage in wiring

Charles Hoffman of Hazlet asked if we normally make Contracts with Police Department. Chairman Sutton explained if we worked on public roads we are required to use the police department for traffic control. Mr. Hoffman said he is aware of that but there are other towns serviced by the BRSA. Pete said Hazlet is the only town that has requested it.

Charles Hoffman asked about the surplus material auction sale. He asked how BRSA could sell Personal Property. John Napolitano explained that there are 2 kinds of property - real property (real estate) and personal property (anything that can be moved). The Authority is not auctioning off any personal property as Mr. Hoffman is referring to it, but personal property in the form of surplus equipment no longer needed.

**WHEREAS**, the Authority Engineer and Director have met with the staff of PS&S to review the amendment proposal and find the amendment request dated August 14, 2015 to be fair and reasonable and represent work that was beyond the original or amended scope; and

WHEREAS, funds are available for this purpose.

The Board said they would discuss the issue in Closed Executive Session and get back to them.
