# MINUTES REGULAR MEETING MONDAY, MARCH 21, 2016

At 7:04 P.M. on Monday, March 21, 2016 Chairman Pisano called the meeting of the Bayshore Regional Sewerage Authority to order and makes the following announcement:

I hereby announce that pursuant to Section 5 of the Open Public Meetings Act, that adequate notice of this meeting has been sent to the Asbury Park Press and is on the BRSA Official Website. Notice has also been sent to the Clerks of Aberdeen, Hazlet, Holmdel, Keansburg, Keyport, Matawan, Union Beach and Marlboro and the Western Monmouth Utilities Authority. This notice is also posted in the lobby of the Bayshore Regional Sewerage Authority Administration Building.

Chairman Pisano asked all in attendance to stand for the Pledge of Allegiance and a Moment of Silence for the safety of US Troops all over the world.

## Reports

1. Executive Directors Report, BRSA Projects, Special Reports & Connection Applications Mr. Robert Fischer Reported:

# Projects During the month of March the following Contractors Completed:

- Stone Hill Construction worked on the Niro Project including installation of cable trays, control panels, structural support, duct work and new electrical
- Northeast Remsco worked on the Pump Station Project installing the MCC on the raised floor, installing new MCC, new feeders from the switch gears to the MCC at a higher elevation and contractors are about a month away from testing pump #1 & #3. At that point ½ of our equipment will be operating at the higher level.

• Shorelands worked on Various Authority Buildings Project installed spray liner protection in Lab/Office Building, reinstalling brick face on the flood walls, and installing piles at Return Sludge Pump Station #2 which was designed because of the potential wave impact.

Funding Regarding the NJEIT Sandy Funded Phase I Projects:

- Requisition #9 in the amount of \$3,228,377.97 was paid. Of that, \$1,819,533.12 was submitted to FEMA for reimbursement and \$108,189.23 was submitted to the SAIL Loan Principal Forgiveness which we expect 19%
- Stone Hill Construction submitted Payment #10 in the amount of \$802,098.82 Remsco Contracting has submitted Payment #6 in the amount of \$401,705.28 Shorelands Construction has submitted Payment #4 in the amount of \$152,695.52
- NIRO project is 70% complete Pump Stations is 45% complete Various Buildings is 60% complete
- Cumulative Phase 1 project payments excluding March claims is \$13,164,953.81.

**EPA SSI Regulations** 

• Mr. Fischer had a conference call meeting with the Legal Committee and a letter went out to the DEP and EPA advising them that the Authority intends to continue running the Dorr Oliver consistant with conversations with the Acting Director for Air Compliance at the EPA and the EPA attorney. The BRSA is continuing to run the Dorr Oliver Incinerator and seeking an Administrative Order authorizing the operation of the Dorr until the NIRO is complete later this year. We estimate a 6 month start up, the contractors estimate 3 month, and we asked for 9 month extension to cover any delays. As of today we are still running the Dorr Oliver.

# 2. Staff Engineer Report Peter Canal Reported:

• Approve Sewer Connection & TWA for Monarch Pointe in Marlboro. We have received the full payment of \$136,646 however the developer has asked to hold the Resolution (#48/16), return the payment and request a Developers Agreement next month.

The Developer and their Engineer from DW Smith addressed the Board.

John Napolatano excused himself because his partner Sal had represented the Developer in the past. He stepped down to sit in the audience.

Marcel Gestetner the builder for Monarch Pointe requested the opportunity to phase out the payments with a Developers Agreement.

Pete said we have a standard simple agreement but usually both attorney's like to review it and make changes, however Mr. Gestetner agreed to sign the standard agreement.

Pete also explained that there are 3 payments and the TWA would be signed after the first payment is made.

John Napolitano returned to the Board Table after the Developer was finished.

- Update- Primary Clarifiers 3&4 specifications should be ready in a couple of weeks and award should be ready for May's meeting.
- Update -West Keansburg Force Main Rehabilitation is 100% complete. A change order is being prepared for next month's meeting and the Authority will close out this project.
- Award of the Annual Calibration & Repair of Flow Meters Instrumentation to ABB in the amount not to exceed \$19,307.
- Award the Comminuter and Accessories for the Matawan Pump Station to Franklin Miller, Inc. in the amount not to exceed \$55,950. Staff will do installation
- Update Combined Blower Building 1&2 very close, final comments from the State. Hazen and Sawyer are cleaning them up. Half of DEP signed off on it. Expecting authorization to advertise before May meeting.

# 3. Consulting Engineer – R3M Manuel Ponte Reported:

- Various Authority Buildings Update Mr. Ponte advised the Board that most of Shorelands work is complete. The delay in closing out the project is due to the Authority Need to use the same flood panels for the projects.
- General Project Updates Generator #3 is completed, they are working on #2, then #1. Generators #1 & #2 will have new radiators-which are sitting in the port right now.

Mr. Fischer advised the Board that he asked Manuel Ponte to come in Thursday to meet with the Staff to discuss the intermittent odors complaints we still get. It's difficult with the construction going on because the doors are left open for construction work. We need to do an overall assessment of the plant and target certain areas for improvement. We did put funds in the budget this year to enhance the odor control system in the plant. Our present odor control system is over 20 years old.

#### 4. Superintendent's Report

- With the wet weather the plant flow back up to normal at an average of 8 mgd.
- Plant effluent quality is good, still less that 50% of the NJDEP limits.
- The Dorr Oliver has been running however repairs were done for 2 days.
- No odor complaints in February but had some for the beginning of March.
- Anthony Rotundo of DEP visited the plant for the Annual Compliance Evaluation & Assistance Inspection—he indicated minor concerns about the our NJPDES Stormwater Permit with reference to the storage of materials and trash from the construction projects. The concerns were relayed to the contractors.
- BRSA received its 12<sup>th</sup> consecutive annual safety award from JIF
- Annual report by IPP some issues resolved.
- Completed and submitted the NJPDES Permit Annual report for our Industrial Pretreatment Program to NJDEP which details activities of our Local Delegated Agency Industrial Pretreatment Program

Commissioner McMullen asked about the staff dropping off the daily enterococci sample to Lyons Environmental Services to save the \$40 per day pick-up fee. Mike Broyles said that an employee on light duty has been taking an authority vehicle and driving the sample down.

Last week IFF Compounding Facility had a problem with their contracted laboratory and R&D had a problem with a flow meter and they were told they would have to estimate the flow. Other than that all have been in Compliance.

Commissioner Steiner asked about the dishwasher in the lab. Mike told him that it is a special glassware dishwasher made just for labs with a special rinse cycle. Replacement would be several thousands of dollars. Staff performs repairs to keep it running.
