REPORTS

Executive Directors Report, BRSA Projects, Special Reports & Connection Applications Mr. Fischer Reported:

Disaster Recovery Update

- Phase II Combined Blower Building-Contract 80S- almost finished, working on Control System that maintain dissolved oxygen in the aeration basin.
- Power Distribution System Contract 81S- T1, T2 & T3 have been delivered and installed. We should see T4, T5 & T6 sometime in the spring, earlies would be February.

Power Resiliency Project

• Meeting on Dec. 5th with NJOEM & FEMA to clarify and make sure everyone understands the requirements for the design so there are no questions when it comes to reimbursement.

<u>Other</u>

• 2018 Line Item Budget – an amendment to move appropriations from an underspent line item to a soon to be overspent line item. There will be no change in the budgeted total appropriations.

• Conservation Restriction/Easement Agreement with DEP – original agreement was issued with the 1991 CAFRA permit for the expansion of the treatment plant which was over restricted. Brian McPeak of PS&S presented his findings and explain the new agreement.

- Furnish & Deliver Caustic Soda (Sodium Hydroxide) extend contract to Kuehne Chemical for a one year period in the amount of \$210,852. No increase in rates or charges in contract.
- Furnish & Deliver Fuel Oil received 2 bids. Lowest bidder is Griffith Energy (aka Allied Fuel Oil Co.) in the amount \$210,852. Other bid from Petroleum Traders Corp. in the amount of \$217,456.

- Lab did the make-up fecal coliform proficiency test and passed resulting in the Authority to maintain it's Certification.
- Inspected NJ Turnpike facility. Everything very clean, sample taken received no hits.
- Maintenance conducted hydrogen sulfide test at West Keansburg Pump Station Force Main. Adjusted Bioxide feed for colder months ahead.
- Maintenance raised a few manholes and completed clearing BRSA easements. Mr. Fischer commented that despite all the projects on going and the various tanks on line/off line the effluent is very very clear and we maintain a very good removal at 95%. He said the Plant really runs well. Chairman Steiner said that goes to a good staff for making that happen.

RESOLUTION No. (102/18); To Authorize Dental Benefit Coverage with Delta Dental For 2018/2019

WHEREAS, Bayshore Regional Sewerage Authority provides its employees with dental benefits through Delta Dental; and

WHEREAS, in a memorandum dated October 16, 2018 Delta Dental of New Jersey offered 12 month coverage rates at \$47.71 per month for one (1) party coverage, \$92.30 per month for two (2) party coverage, and \$158.84 per month for three (3) party coverage; and

WHEREAS, the Authority emergency generators are rated for only 24 hours; and

WHEREAS, the Authority submitted a Hazard Mitigation Plan for Power Resiliency System for the BRSA and Monmouth County Bayshore Outfall Authority Union Beach Facility; and

WHEREAS, on September 13, 2018, the Federal Emergency Management Agency (FEMA) authorized a detailed design of the proposed Power Resiliency System; and

WHEREAS, on November 1, 2018 the Engineering Committee met to review the procurement requirements for the project and are recommending the Authority follow the Federal Procurement Standards and seek Request for Qualifications from firms on the 2018 Engineering News Record (ENR) top 100 list; and

WHEREAS, the Authority requires authorization to solicit proposals from engineering firms listed on the 2018 ENR top 100 list, who have design experience with both wastewater treatment plants and power generation systems; and

NOW THEREFORE BE IT RESOLVED the Commissioners of Bayshore Regional Sewerage Authority authorize the Executive Director and Chief Engineer to seek Request for Qualifications following the Federal Procurement Standards for engineering firms listed on ENR top 100 list with design experience in both wastewater treatment plants and power generation systems.

WHEREAS, the Qualified Purchasing Agent and the Authority Engineer have reviewed the correspondence with Kuehne Chemical Company, Inc. accepting the one (1) year extension in accordance with the same product, price, terms and conditions as the original Contract and are recommending a one year extension; and

WHEREAS, the Authority has a need for a centralized storage facility of its spare parts and archived files; and

WHEREAS, R3m Engineering, Inc. submitted an engineering design for the Repurposing of Blower Building No.1 to Storage Building with Conception Alternative Layouts, in the amount of \$39,800; and

WHEREAS, the Chief Engineer and Director have met with the staff of R3m to review the proposal and find it to be fair and reasonable; and

WHEREAS, in accordance with <u>N.J.S.A.</u> 5:30-5.4 (a) (3), the Authority certifies the availability of funds in the Unrestricted Net Position line item, to cover the maximum dollar value of the pending contract as set forth in this Resolution.

WHEREAS, on March 11, 1992 the Department of Environmental Protection (NJDEP) issued a Coastal Area Facility Review Act (CAFRA) permit to the Bayshore Regional Sewerage Authority ("Authority") for the proposed expansion of its treatment plant from 8 MGD to 16 MGD; and

WHEREAS, Administrative Condition #4 of the CAFRA permit required the Authority to create a restriction within the property to assure that a restricted wetlands buffer area be maintained and to prevent any disturbance or development within that portion of the Property; and

WHEREAS, on July 20, 1992 the Authority filed a Deed of Restriction with the Monmouth County Clerk's office satisfying this CAFRA permit condition; and

WHEREAS, pursuant to the 2016 CAFRA Permit, the Authority and the NJDEP have agreed that the 1992 Conservation Restriction included areas of the plant's property that should not have been restricted in 1992 and therefore the Deed of Restriction should be rescinded and revised; and

WHEREAS, the Restricted Area established by the 1992 Conservation Restriction is almost entirely composed of impervious surfaces within the plant's fence line and maintained landscaping area; and

WHEREAS, the Authority and the NJDEP are in favor of rescinding the 1992 Conservation Restriction and creating a new Conservation restriction which is not composed of impervious surfaces within the plant's fence line and maintained landscaping area; and

WHEREAS, the Authority and the NJDEP specifically agree to the terms and conditions of the attached "Grant of Conservation Easement/Restriction (DEP File No. 1350-90-0004.1, .4, .5 and 1350 09 002.1).

NOW THEREFORE, the Commissioners of the Bayshore Regional Sewerage Authority agree to the rescinding of the 1992 Conservation Restriction and for other valuable consideration, the receipt and sufficiency of which is acknowledged and contained within the attached "Grant of Conservation Easement/Restriction" hereby approve the "Grant of Conservation Easement/Restriction" and authorize the Chairman and Secretary to execute same.

BE IT FURTHER RESOLVED, the Grant of Conservation Easement/Restriction be filed with the Clerk of Monmouth County in the appropriate Deed Book and evidence thereof be sent to the NJDEP.
