Disaster Recovery Update

- Phase II Combined Blower Building-Contract 80 still working on the bugs in the Control System.
- The Restoration and Mitigation of the Power Distribution System 3 of the enclosures are on their support structure and work is being done to heat the units for the winter. The remaining enclosures

should be in around February with a possible close-out the end of May, beginning of June.

Security

- Replacing the camera's that are facing the front gate and the parking lot
- Replacing the Network NVR (Network Video Recorder) so additional cameras could be placed around the facility. This would allow the incinerator operators to monitor the certain processes without leaving the incinerator unattended.

Other

- The 2019 Budget has been adopted and will be sent down to the DCA this week and the new charges will be sent out to the participating towns.
- Purchasing Cooperatives membership in two cooperative purchasing systems for NJ local government members. This will saving the authority time and money.
- Union Beach Fire Dept. seeking donation.

Pete Canal:

- Belt Filter Press Access Stair Replacement-RFQ2018-4 to lowest price \$25,400. Recommend award to lowest bidder Iron Hills Construction.
- Rehabilitation of 4 Sludge Concentration Tanks and replacement of our sludge pumping systems No. 1 & No. 2. Five bids were received and opened on December 5th, ranging from \$3,912,445 to \$3,439,000 recommend award to lowest bidder Spectrasery, Inc. @ \$3,439,000
- Annual Calibration & Repair of Flow Meters Instrumentation-contract expires March of 2019. Seeking Resolution to authorize public advertising the RFQ on BRSA website.
- Geographical Information System Mapping (GIS) rescind the November GIS resolution #106/18.
 Maser informed us their proposal was submitted under a Fair & Open Process however we informed Maser it was a Non-Fair and Open process. Both agreed to rescind the resolution.
 After advertising on our website for 10 days, on December 14th one sealed proposal was opened from Maser Consulting PA, in the same amount of \$34,785. Recommend award to Maser Consulting of Red Bank, NJ.

- Condition-Assessment & Planning Program for Internal Inspections of Force Mains completed draft report on results and recommendations from Pure & submitted to BRSA. Met with Pure and BRSA Staff to review and will address BRSA's comments.
- Odor Control Systems #2, #3,#4 all in operation with new internals except for Scrubber #4 waiting for new fan to arrive and to be installed.
- Scrubber #4 has a NJDEP Permit. Contractor needs to inform the DEP it was refurbished and an Air Permit Stack Test must be scheduled and performed to assure Scrubber #4 passes the limits for H2S and Mercaptans.
- Working on former Blower Bldg. #1 to develop concept for parts & equipment storage.

Superintendent's Report Mike Broyles Reported:

- Flow for November was up slightly for the month.
- Effluent numbers are excellent with 98% removal
- Received 1 voice message odor complaint from Mr. Lauro stating it was good on Thanksgiving but bad the day after.
- Incinerator down 3 days due to Iron Hills Construction taking down Odor Control Tower #4 to perform rehab work. Title V Air Permit prohibits dewatering of sludge when the system is down. Operations used the shut-down to remove some sand from the incinerator and wind box.
- New lab personnel working out well and moved to new schedule with Tuesday & Wednesday off.
- New Fire Walls installed to upgrade and improve cyber security on our computer system.
