REPORTS

Executive Directors Report, BRSA Projects, Special Reports & Connection Applications Mr. Fischer Reported:

Disaster Recovery Update

- NIRO project has been the same for the last few months, a few things still have to be closed out
- Pursuing an extended warranty of the CPPE Mercury removal system.
- Combined Blower Building is primarily complete except the commissioning of the control system for the valves and some punch list items. This project should be closed in the next 2 months.
- PKF- raising of the Power Distribution System-the manufacturer of the switch gear enclosure (Cruz and Wagner) filed Chapter 7 last week. The factory acceptance test was scheduled for July 11th and when PKF &GE flew out to witness the test were refused entrance due to an "emergency employees meeting". As it stands now there were 5 enclosures and 1 main switch gear. T1, T2 and T3 are complete and waiting for factory acceptance test. T4,5 &6 the gears are built but not the enclosures. They were waiting for T1,2&3 to be shipped out to make room on the floor to build T4,5 &6 enclosures. The main gear enclosure has been built but the gear has not been sent over. Of all 6 components 3 are complete. We had a meeting today with PKF to find out how we get that equipment shipped to the Authority. GE had a high level meeting today and get back to PKF tomorrow to give them an update. Logically they should release the completed components and get that money but the legal process will have to take its course. We may have to direct GE to have the components made by someone else and that will take about 6 months. The good news is that the BRSA and PKF has not paid a dime towards the equipment.

Commissioner Cavanagh asked who owns the equipment. Mr. Fischer said GE.

John Napolitano said we probable have to go through a bankruptcy lawyer.

Commissioner Sutton asked John if we could get Homeland Security involved. John said we could asked FEMA to intercede with the bankruptcy court.

Mr. Fischer continued with PKF's plan to put all the power into T2. T1 is has been removed but it is on site, by their requirement, so if something happens to T2 they could put T1 back on line. If this goes long term we will have PKF move T1 back in place or have wires set up so if something happened to T2 they could get out here and connect T1 to get us back up.

Disaster Funding

- PKF Mark III submitted payment application #8 in the amount of \$42,402.64
- On Wednesday, May 16th the Authority staff, Consulting Engineer, NJOEM & FEMA in reference to Change Orders from Contracts 71S,72S, 73S, 74S. FEMA had a lot of questions which we answered and they are reviewing the paperwork for approval.
- On June 22nd a conference call was placed with our consulting engineer, authority staff and FEMAquestions regarding the power resiliency project. FEMA wanted to know the placement of the units, and the sizing of the units. There is a feeling FEMA is working with us in regards to this project.

Collective Bargaining Agreement

• Nothing new with negotiations. Waiting for people to return from vacation.

R3M/Pure Technologies

• Completed the inspection of all three sewage pump station force mains using the "Smart Ball" on Raritan Valley & Keansburg and the "Pipediver" on Matawan by Pure Technologies.

Ethan from Pure Tech. and Mike Samuels from R3M explained the difference between the smart ball and pipediver, how they work and the information each one will provide.

• Meeting with the DEP in Trenton today in reference with the permitting of the Dorr Oliver Incinerator. The DEP is considering the Dorr Oliver as an existing incinerator. Both the NIRO and Dorr Oliver incinerators far exceed the stack test requirement.

WHEREAS, there is a need to amend the Contract to credit a change in the scope of work for the deletion of resin injection tubes in the amount of \$9,075.00; and

WHEREAS, the Authority and its Consulting Engineer, R3M Engineering, Inc. have prepared Change Order No. 1, dated 7/2/18 to amend the Contract, in the credit amount of \$9,075.00.

<u>RESOLUTION No. (79/18)</u>: To Authorize an Engineering Amendment to Chavond Barry Engineers for re-testing of NOx during the Stack Test of NIRO Incinerator, in the amount of \$9,100.

WHEREAS, through Resolution 53/18, the Bayshore Regional Sewerage Authority (the "Authority") contracted with Chavond Barry Engineers ("CBE") for the Annual Stack Test of NIRO Incinerator for an amount not to exceed \$67,600; and

WHEREAS, the Authority previously approved Resolutions No. 67/18 for Amendment No.1 in the amount of \$11,761.91 for delays due to operational problems caused by unexpectedly high sludge concentrations, resulting in high incinerator temperatures; and

WHEREAS, due to the unexpected high sludge concentrations during testing, the emissions measured during testing indicated that NOx on a lb/ton and lb/hr basis were not in compliance with Bayshore's permit and NJDEP is requiring re-testing; and

WHEREAS, CBE and their sub-consultant Gammie Air Monitoring, Inc. submitted a proposal dated June 20, 2018 for Amendment No. 2, in the amount of \$9,100 for fees to perform the NOx retest; and

WHEREAS, the Authority Chief Engineer and Executive Director have reviewed the amendment proposal and find the amendment request dated June 20, 2018 to be fair and reasonable and represent work that was beyond the original scope of work; and

WHEREAS, in accordance with <u>N.J.S.A.</u> 5:30-5.4 (a) (3), the Authority certifies the availability of funds in the Testing and Analysis line item, to cover the maximum dollar value of the pending contract as set forth in this Resolution.

NOW THEREFORE BE IT RESOLVED, the Commissioners of the Bayshore Regional Sewerage Authority hereby approve a contract amendment No.2 in the amount of \$9,100 to Chavond Barry Engineers of Blawenburg, NJ in accordance with the terms and conditions of its correspondence dated May 8, 2018, increasing their budget amount to \$88,461.91.

WHEREAS, the Authority is desirous of upgrading the existing pump control PLC's due to their age, failure history and difficulty in obtaining parts; and

WHEREAS, a failure of the Matawan or West Keansburg Pump Stations would impact the health, safety and welfare of the Authority staff, surrounding community and environment; and

WHEREAS, Morehouse Engineering ("Morehouse") the Authority Process Control and Instrumentation Consulting Engineers has provide the Authority with a professional services proposal to design the new control systems, provide the Authority with a material list for Authority purchase and provide support services for the Authority installation of the new control systems at Matawan and West Keansburg Pump Stations; and

WHEREAS, the time and expense proposal cost of \$67,370 has been reviewed by the Authority staff and found to be reasonable for the scope of services provided; and

WHEREAS, the Local Public Contracts Law provides an exemption from competitive bidding of contracts for professional services; and

WHEREAS, in accordance with NJAC 5:30-5.4(a)(3), the Authority certifies the availability of funds in the unrestricted net position line item of the capital budget, to cover the maximum dollar value of the pending contract as set forth in the Resolution.

NOW THEREFORE BE IT RESOLVED, the Commissioners of the Bayshore Regional Sewerage Authority hereby award a contract in the amount of \$67,370 to Morehouse Engineering, Inc. of Hopewell, NJ in accordance with the terms and conditions of its proposal dated June 27, 2018.
