## <u>MINUTES</u> <u>REGULAR MEETING</u> <u>MONDAY, MARCH 19,2018</u>

At 7:00 P.M., Chairman Steiner made the following announcement:

The Regular Meeting of the Bayshore Regional Sewerage Authority will now come to order. I hereby announce that pursuant to Section 5 of the Open Public Meetings Act, that adequate notice of this meeting has been sent to the Newark Star Ledger and Asbury Park Press. Notice has also been sent to the Clerks of Aberdeen, Hazlet, Holmdel, Keansburg, Keyport, Matawan, Union Beach and Marlboro and the Western Monmouth Utilities Authority. This notice is also posted in the lobby of the Bayshore Regional Sewerage Authority Administration Building.

Chairman Steiner asked all in attendance to stand for the Pledge of Allegiance and a Moment of Silence for the safety of US Troops all over the world.

Chairman Steiner called for a roll call of attendance: **PRESENT:** Commissioners Cavanagh, Khachaturian, McMullen, Sutton, Whalen and Chairman Steiner

## **REPORTS**

### **Executive Directors Report, BRSA Projects, Special Reports & Connection Applications** Mr. Fischer Reported:

### Disaster Recovery Update

- Contract 74S-NIRO- is down to 6 punch list items and very close to completing this project.
- Contract 80S-Combined Blower Building- is about 85% complete and moving along very well with a May 18<sup>th</sup> completion date.
- PKF is working on pile caps and waiting on equipment. By April, the enclosure and steel support structure will be in.

#### Disaster Funding

- Stone Hill-Combined Blower Building-submitted payment #18 in the amount of \$324,237.90.
- PKF has submitted payment # 5 in the amount of \$221,017.93.

### Loan Closing

• Commissioner Khachaturian and Chairman Steiner have been signing a lot of papers for the Principal Forgiveness Portion. The Long Term Loan will close sometime in May. We have the numbers all worked out and the Long Term Loan amount looks like \$11.2 M.

### Annual Stack Test

- The last Stack Test on the NIRO Incinerator was completed in April, 2017. The Title V Permit regulating our emissions limits require a Stack Test from no less that 11months and no more than 13 months from last test. Our next Stack Test is scheduled for April 2<sup>nd</sup>. This test will be a little different to achieve 2 operating scenario's. One before the Mercury Scrubber and one after the Mercury Scrubber to allow us to continue to burn in the event the scrubber were to fail.
- A Resolution is on the agenda to hire Chavond Barry as the Incinerator Engineer who will use Gammie Air to perform the Stack Test.

### <u>Other</u>

- Collective Bargaining Agreement expires on March 31, 2018. The union will be meeting on March 26<sup>th</sup> to come up with their proposals.
- Capital Budget Amendment to account for a shift of funds among line items and to add an additional project. The additional project is the refurbishment and improvements to Odor Control Systems 2-4. The funding for the Dorr Oliver Incinerator Rehab Project investigation phase & permitting will be reduced to allow for the needed funds for the Odor Control Project. No additional funds are needed.

### Staff Engineer Report Pete Canal Reported:

- Award R3M Engineering the design services for Odor Control Systems #2, 3, & 4 in the amount not to exceed \$54,929.00
- Award Contract 102 to Polydyne Inc. for the annual furnishing & delivery of liquid Polymer in the amount not to exceed \$125,000 for a two year period.

Commissioner McMullen asked how much higher is this bid compared to their last one. Pete said approx. 25% increase. Polydyne would not extend the last contract due to price increase.

• Award Contract 103 to Karl Deigert Enterprises for Annual Standby Repair & Services in the amount not to exceed \$461,191.50 the lowest of 4 bids. The bid came in at \$455,293.55 however R3M found a math error in mobilization bringing it to \$461,191.50.

Commissioner Cavanagh asked Pete if he took any exceptions to the bid. Pete said no and also the Attorney reviews the bids and took no exceptions to the bid either.

Mr. Fischer asked how much of the bid is actual work and how much is based on estimated quantities of how much we will use throughout the year. Manuel Ponte said the scope of work is already designed at approx. \$177,000 and the rest is just budgeted in case we need it. This was reviewed by the Engineering Committee.

• Award R3M Engineering a contract for the Construction Management Services for the Annual Standby Repair & Service Contract #103 in the amount not to exceed \$45,440.00

 Award R3M Engineering (with Pure Technology-pipe diver & smart ball) a Condition Assessment and Planning Program for the inspection of BRSA's force mains in the amount not to exceed \$332,880.00. The breakdown comes to 23% for West Keansburg, 70% for Matawan and 7% for Raritan Valley.

Mr. Fischer said we required higher insurance limits on this project similar to a construction project and spoke to Mike Samuel about assurances that the equipment can pass through the pipes. Mike said that is what the pre-inspection is all about and he will give us his recommendation before they insert anything into the pipe.

Commissioner McMullen asked why we are going through R3M instead of Pure going directly with us. Pete said R3M has worked with Pure and there is work that both of them are going to be doing together. R3M will pass the Pure Technologies portion through without mark-up.

#### **Consulting Engineer – R3M Manuel Ponte Reported:**

Manuel said he gave Pete his recommendation to award the Standby Repair & Service contract to Deigert for emergency purposes however a catastrophic situation may be out of their scope of work which leaves the Authority open to hire someone else. Pete said Roy has used them out a West Keansburg Pump Station on a water line.

- The flow for February is up from last month and close to the normal flow due to rain & snow melt.
- Suspended Solids and BOD's are low on the effluent
