REPORTS

Executive Directors Report, BRSA Projects, Special Reports & Connection Applications Mr. Fischer Reported:

Disaster Recovery Update - Phase II

• Combined Blower Building-Contract 80 – is ready to be closed out. Hazen is here to discuss the Closeout and Pete will comment in his report. Only one Superstorm Sandy project left to complete is the Restoration and Mitigation of the Power Distribution System. The T4 enclosure will be here in February, T5 & T6 in March and the Main Switch Gear in April.

Security

• The Authority is replacing and upgrading the Security Camera System within the Treatment Plant. Pete will discuss the quotes received last week.

Other

- The 2019 Budget has been certified by the DCA and the new charges were sent out to the towns.
- Dorr Oliver Rehabilitation and Upgrade Project Hazen has been working on the feasibility and permit. A structural analysis is needed to determine where the components are going to be installed in the Dorr Oliver building. Very few structural changes are permitted.
- Pay-To-Play Non-Fair and Open Policy prohibits the professional in making contribution one year prior to and during their Contract with the Authority. If the Commissioners have no objection we'll ask the existing professionals for proposals.
- A Proposal was received from R3M Engineer for Engineering Support Services to assist with written requests for qualifications review, recommendation and negotiating a price with the most qualified Firm for the Power Resiliency Project.
- Resolution to Purchase a truck to replace the oldest and most costly vehicle and also purchase a utility vehicle for plowing walkways, salting and access to easements. Both vehicles are under budget.

Staff Engineer Report

Pete Canal:

• Sludge Concentration Tanks Rehabilitation & Improvement-Contract 106- awarded to Spectraserv in the amount of \$3,439,000. PS&S provided a proposal for Construction Management & Inspection Services in the original amount of \$439,930 was reduced to \$372,520 by reducing on-site inspections since BRSA Engineers can supplement part of that service. Rich Crane from PS&S explained their proposal.

Mr. Fischer asked Pete to explain Contract 106 and the review of the Management Proposal. Pete said Construction Contract 106 was in the amount of \$3,439,000, the Design Services was 7%Engineers Management and Inspection Services is just under 11% total Engineers is under 20% for the entire project. This project is a 24 months project due to operational constraints.

Dorr Oliver Incinerator Upgrade Evaluation – completing the 2nd phase which is the Permit submission to the NJDEP, Hazen was asked to move forward to Phase 3-Conceptual Structural Analysis. Hazen has submitted a proposal for the Structural Analysis in the amount of \$79,929. Ed Barboe and Julian Chianelli presented their proposal.

Mr. Fischer stated that every Authority needs to have a Sludge Management Plan and a Back-up Plan. The Dorr Oliver Incinerator is our Back-up Plan.

- Combined Blower Building-Contract 80S-two resolution (1) to close-out the contract and (2) for final amendment to Hazen in the amount of \$140,000 for construction inspection services. John Wojnas and Ed Barboe from Hazen explained the close-out and final amendment.
- Odor Control Improvements, System #2,3&4-Contract 105- all work is done final Change Order No.1 in the amount of \$3,679.94 to Iron Hills Construction.
- Annual Jet Vacuuming Services-one-year extension to North American Pipeline Services in the amount of \$24,000.
- Security Camera System Upgrade-award RFQ to Leading Edge Technology Services in the amount of \$29,425.

Consulting Engineer – R3M Manuel Ponte Reported:.

- Odor Control Systems #2, #3, #4 all work is done except for the Emissions Test for Scrubber #4 which is the only Scrubber of the three to have a permit, the others do not. The contractor's consultant called the NJDEP to schedule the test and they were told the DEP was very busy, call back in February.
- Blower Building #1 conversion to a Storage Building contains 2 rooms (1) for parts & equipment and the smaller one for records. Conceptual drawings have been submitted to BRSA staff for their suggestions and input. Also working with the Union Beach Code Enforcer for review to determine if approvals are necessary.

Superintendent's Report

Mike Broyles Reported:

- Flow for December was down slightly for the month.
- Effluent numbers are excellent with 98% removal
- There were no odor complaints for December
- JIF Inspection recommended in the Pressroom an indoor Air Quality Program. NJPEOSH has an indoor Air Quality Regulation even though the Federal Government does not. The Regulation requires a go to person in case anyone has a concern or complaint. Chuck, Roy and Mike attended the training session and will prepare a written program.
- Industrial Pretreatment Mike and Chuck inspected all 4 Industrial user locations. All operating Normally.

WHEREAS, a Title V Air Permit ("Permit") Application has been submitted to the New Jersey Department of Environmental Protection (NJDEP) to amend the Permit to allow for the upgrade and operation of the Dorr Incinerator consistent with the SSI regs; and

WHEREAS, Hazen Engineers has submitted a proposal to the Authority dated January 3, 2019 to develop mechanical equipment layouts and perform a structural analysis on the impact of those equipment layouts on the Dorr Oliver Building at a cost not-to-exceed \$79,929; and

WHEREAS, the mechanical equipment layouts and structural analysis is the final phase of the feasibility study which included evaluating the Dorr Oliver Incinerator as an existing incinerator under State and Federal definitions, as well as submitting a permit modification to the BRSA Title V Permit to include the modified Dorr Oliver Incinerator; and

WHEREAS, the Chief Engineer and Executive Director have reviewed the proposal and find it fair and reasonable for the defined scope of work; and

WHEREAS, in accordance with NJAC 5:30-5.4(a)(3), the Authority certifies the availability of funds in the Unrestricted Net Position of the Authority Capital Budget, to cover the maximum dollar value of the pending contract as set forth in the Resolution.

WHEREAS, the Authority submitted a Hazard Mitigation Plan ("HMP") for Power Resiliency System for

the Authority and Monmouth County Bayshore Outfall Authority's ("MCBOA") Union Beach Facility; and **WHEREAS**, on October 18, 2018, the Federal Emergency Management Agency ("FEMA") authorized a detailed engineering design of the proposed Power Resiliency System; and

WHEREAS, Resolution 103/18 authorizes the staff to prepare a Request for Qualifications, in accordance with Federal Procurement Standards; and

WHEREAS, R3m Engineering, Inc. ("R3m") submitted a proposal dated January 4, 2019 for engineering support services relating to Standby Power Resiliency Facilities for the Authority Treatment Plant, in the amount of \$28,000; and

WHEREAS, the Chief Engineer and Director have met with the staff of R3m to review the proposal and find it to be fair and reasonable; and

WHEREAS, in accordance with <u>N.J.S.A.</u> 5:30-5.4 (a) (3), the Authority certifies the availability of funds in the Unrestricted Net Position of the Authority Capital Budget, to cover the maximum dollar value of the pending contract as set forth in this Resolution
