MINUTES FOR REGULAR MEETING MONDAY, MAY 20, 2019

At 7:02 P.M., Chairman Whalen makes the following announcement:

The Regular Meeting of the Bayshore Regional Sewerage Authority will now come to order. I hereby announce that pursuant to Section 5 of the Open Public Meetings Act, that adequate notice of this meeting has been sent to the Asbury Park Press. Notice has also been sent to the Clerks of Aberdeen, Hazlet, Holmdel, Keansburg, Keyport, Matawan, Union Beach and Marlboro and the Western Monmouth Utilities Authority. This notice is also posted in the lobby of the Bayshore Regional Sewerage Authority Administration Building.

Chairman Whalen asked all in attendance to stand for the Pledge of Allegiance and a Moment of Silence for the safety of US Troops all over the world.

Chairman Whalen called for a roll call of attendance: **PRESENT:** Commissioners Cavanagh, Khachaturian, McMullen, Steiner, Sutton and Chairman Whalen

Reports

Executive Directors Report, BRSA Projects, Special Reports & Connection Applications Robert Fischer Reported:

- Power Distribution Enclosures # 5 & 6 are scheduled to be shipped in June along with the Main Switchgear. Final completion date is December 2019.
- Request for Qualifications (RFQ) were sent out to engineers on the Power Resiliency Project. The qualified engineer will design and provide construction management services.
- John Draikiwicz Bond Counsel explained the Phase II Long Term Loan closing which is set to take place on May 23rd. The loan of \$2,552,467 is 75% with Zero % interest, and the remaining loan of \$935,000 makes up the additional 25% of the total loan. I-Bank sold the bonds at their AAA credit rating at an interest rate at 2.429% over twenty years making the total interest rate of approx. 0.6% over twenty years.

Commissioner Cavanagh asked John Draikiwicz if the I-Bank is a government sponsored bank. John said it was formed as an entity to issue Infrastructure Bond for Infrastructure Project.

Mr. Fischer stated that we borrowed short term funds of \$25.2 million in Phase I and \$12.6 million in Phase II for a total of \$37.8 million. We have repaid a substantial portion of that amount with FEMA Funding. As a result our final long term debt service is \$11 million in Phase I and \$3.5 million in Phase II totaling \$14.5 million for all the work that was done to recover from Sandy. Consequently, our yearly debt service payment is less than \$1 million for twenty years.

- Cyber Security Policies Mel (Municipal Excess Liability) under NJUAJIF has created cyber security technology practice and security response policies that will provide deductibles should an attack occur.
- Summer Intern Program Asset Management Program and GIS Program requesting to hire 2 college student engineers from Rutgers (one is Chemical Engineer and one is Mechanical Engineer) to help with data input at a pay rate of \$15.00 per hour to commence on May 27th thru the end of August.

Pete informed the Commissioners that Tom Petti took the PE test and passed. He also holds a C-1 State License.

• Emergency Repair of the Main Pump Station Discharge Header – staff spotted a leak where the support piping is welded to a flange plate. Corrosion on the welded area and in the interior of the thrust pipe caused leakage. This pipe and flange has been there since 1974.

- RFQ for Annual Cleaning & Video Inspection of the sanitary sewer interceptors authorization to advertise for yearly contract on BRSA web site.

- 2nd Quarter 2018/2019 Flow Report Manuel explained that in 2017 the average rainfall was 46 inches. In 2018 the average rainfall was 67 inches which is why you see the increase in flows.

RESOLUTION No. (60/19): To Accept the Six- (6) Month Flow Report for 2018/2019

WHEREAS, R3M Engineering, Consulting Engineers for the Bayshore Regional Sewerage Authority, ("Authority") have determined the quantity of sewage from each of the Towns and Authorities connected to the Authority's system for the period September 26, 2018 to March 27, 2019 (First and Second Quarter of 2018/2019); and

WHEREAS, said flow figures have been reviewed by the Commissioners of this Authority.

WHEREAS, the Bayshore Regional Sewerage Authority ("Authority") owns several buildings at the Treatment Plant located at 100 Oak Street in Union Beach, NJ; and

WHEREAS, the buildings further identified as Blower Building 2, Chlorine Contact Building, and Odor Control Building are eligible for flood insurance under the National Flood Insurance Program ("NFIP"); and

WHEREAS, the Selective Insurance Company will provide total coverage of \$1,500,000 for a total premium of \$4,119 with a \$150,000 deductible; and

WHEREAS, as a condition of FEMA funding the Authority is required to obtain and maintain flood insurance on all eligible buildings; and

WHEREAS, the quoted premiums and coverages have been reviewed by the Authority Risk Management consultants, Conner Strong & Buckelew who has recommended binding these coverages; and

WHEREAS, in accordance with NJAC 5:30-5.4(a)(3), the Authority certifies the availability of funds in the insurance line item, to cover the maximum dollar value of the pending contract as set forth in the Resolution.

NOW THEREFORE BE IT RESOLVED, that the Commissioners of the Bayshore Reginal Sewerage Authority hereby authorize the payment of the above stated premiums to secure flood insurance for the named Authority Buildings for a one-year term according to the building renewal date and instruct the Executive Director to execute all necessary documentation to secure this coverage.

WHEREAS, on or about April 18, 2019 the Bayshore Regional Sewerage Authority ("Authority") became aware that a section of the Main Pump Station ("MPS") header piping was leaking; and

WHEREAS, the leak was a result of internal corrosion at the structural support area; and

WHEREAS, the Authority Maintenance staff made a temporary repair to slow the leak down; and

WHEREAS, upon discovering the leak, the Chief Engineer and Maintenance Superintendent declared this an emergency and invoked the State and Authority emergency procurement policies to secure pricing to make a permanent repair; and

WHEREAS, the pipe leak could not have been reasonably foreseen since sewage header piping cannot be inspected using the techniques employed in gravity sewer lines such as video inspection; and

WHEREAS, three (3) capable contractors who perform this type of work were contacted for pricing; and

WHEREAS, two (2) contractors submitted pricing within the required time period for the bypass pumping and header piping repair, BR Welding ("BRW") in the amount of \$21,565.92 and Iron Hills Construction ("IHC") in the amount of \$45,355; and

WHEREAS, the Engineering staff has reviewed the proposals and are recommending the project be awarded to BRW, in the amount not to exceed \$26,565.92, which includes a \$5,000 parts and repair allowance, if and where directed by the Owner; and

WHEREAS, in accordance with <u>N.J.S.A.</u> 5:30-5.4 (a) (3), the Authority certifies the availability of funds in the Unrestricted Net Position, to cover the maximum dollar value of the pending contract as set forth in this Resolution.

WHEREAS, the Applicant has paid the review fee of \$687.44; and

WHEREAS, the manufacturing of a replacement inclines screw must meet the original design in order to adequately function in coordination with multiple other components; and

WHEREAS, Fairfield Conveyor Service of Michigan City Indiana holds the design of the incline screw and has provided the Authority with a price of \$26,263.82 to manufacture and deliver a new incline screw capable of interconnecting with the multiple components making up Grit System No. 3; and

WHEREAS, the purchase of parts and or service the cost of which exceeds \$17,500 without competitive quotes or bids can only be affected by resolution of the governing body and completion of the Authority Pay-To-Play forms; and

WHEREAS, the Authority Maintenance Superintendent has reviewed the price of the incline screw and considering the interconnected nature of the other components which will remain unchanged has found the cost to be reasonable; and

WHEREAS, in accordance with <u>N.J.S.A.</u> 5:30-5.4 (a) (3), the Authority certifies the availability of funds in the machinery repair and maintenance line item, to cover the maximum dollar value of the pending contract as set forth in this Resolution.

NOW THEREFORE BE IT RESOLVED, that the Commissioners of the Bayshore Regional Sewerage Authority hereby approve the purchase of a newly manufactured incline screw for grit system no.3 from Fairfield Conveyor Service of Michigan City Indiana at a price of \$26, 263.82. WHEREAS, the Authority Chief Engineer and Staff Engineer recommend Gabriel Reis of Elizabeth, New Jersey, a mechanical engineering student at Rutgers University, to fill the position of summer intern to work on the Authority GIS System; and

WHEREAS, in accordance with <u>N.J.S.A.</u> 5:30-5.4 (a) (3), the Authority certifies the availability of funds in the salary line item, to cover the maximum dollar value of the pending temporary employment as set forth in this Resolution.

NOW THEREFORE BE IT RESOLVED, that the Commissioners of the Bayshore Regional Sewerage Authority hereby hire Mr. Gabriel Reis of Elizabeth, NJ as a summer intern to work in the Authority Engineering Department at a rate of \$15 per hour commencing May 27th and ending no later than the last week of August, 2019.
