Chairman Sutton, as well as the group welcomed Mr. Sam Lauro who will be taking over as commissioner next month.

Reports

BRSA Projects, Special Reports & Connection Applications

1. Executive Directors Report

- COVID-19 Policy Update- We continue to monitor and manage policies for Covid-19. 14 employees have tested positive for Covid-19. All have recovered and returned to work.
- Disaster Recovery Update- We have reviewed and commented on final design documents. All permits have been submitted and all, but Title V have been issued. December 21, 2021 scope change was submitted to FEMA and we are waiting a response. DEP is advertising for public comment. We expect to bid the project in late spring 2022.
- Financial January 12, 2022 we met with NJSMUAESA to discuss next years electrical supply contract, we expect to advertise February 28, and receive bids March 30, 2022. The 2020 Audit is still being finalized and the 2021 audit will begin over the next month by Michael Bart's office. The 2022 Operating and Capital budget have been approved by the State and is in effect. Our February 1st bond payment was made. The next bond payment is due August 1st, 2022. There are payments to approve this month for Project Fund (PF) No. 2, for FEMA PW Closeouts to PS&S in the amount of \$3,515 and for PF No.3, for Power Resiliency Generation Project (PRG) for HDR in the amount of \$25,158.30 and R3m engineering, inc. in the amount of \$2,522.50. We are also making our annual electronic appropriation payment to NJPERS in the amount of \$377,432.
- We have Personnel matters for closed.
- Reorganization is scheduled for 2/28/22 at 7pm. Mr. Canal stated he will be following up with appointments and titles prior to the meeting. We plan to continue to seek non-fair and open proposals from all of our exiting professionals.

• Mr. Canal Thanked Commissioner Khachaturian and Commissioner Russo for their time on the Authority's board during some of the most challenging times in the Authority's history. They should feel proud for their contributions, which include keeping rates stable for the last decade.

Commissioner Cavanagh inquired about other Authorities participating in Covid-19 sewerage studies. Mr. Canal responded that there are some Authorities in New Jersey that are participating in the study but at this present time our Authority is not a participant.

2. Staff Engineer Report

- Contract 109- NIRO Spare Primary Heat Exchange Modification & Contract 119 Fuel Oil Tank #3 Replacement are complete. We have a resolution on tonight to close out Contract 119 and accept the maintenance bond. Contract 109 will be closed out in the next month or two.
- RFQ 2022 -01- Administration Building & Main Pump Station HVAC Unit Bids were received on January 11th and we received a low quote from Hutchins HVAC Inc, in the amount of \$39,175.00. We are recommending award of that bid. Therefore, we have a resolution on to award that RFQ to Hutchins HVAC Inc.
- RFQ 2022-02 Furnish & Deliver Main Pump Station Flood Barriers Bids were received on January 11th and we received a low quote from Orange Flood Control LLC in the amount of \$17,355.00. We are recommending award of that bid and there is a resolution on tonight to award the RFQ.
- Dorr Oliver Incinerator Rehabilitation & Upgrades HDR is in the process of developing the Alternatives Analysis report. Once that report is complete and accepted by BRSA, HDR will proceed to the 30% design. We are receiving funds from I-Bank, and are required to complete a Value Engineering (VE) Study. Hazen proposed on the design of the project and successfully completed the NIRO incinerator upgrade. Therefore, we solicited a proposal from Hazen for the VE study in the amount of 54,537.00. There is a resolution on tonight to award the study to Hazen.
- Raritan Valley Force Main Replacement PS&S attended the November 2021 Public Meeting and presented an evaluation study of the force main with the recommendation of replacement. A proposal for the design and bidding services for the project has been submitted by PS&S in the amount of \$230,000.00. We have reviewed the proposal and found it to be fair and reasonable. Therefore, we have a resolution on tonight to award the design to PS&S.
- Interceptor Sewer Rehabilitation Phase 4 Phase 3 is currently in construction. We received two (2) proposals for Phase 4. Jacobs' proposal scored highest in accordance with the pre-advertised weighted RFP criteria. Jacobs is also familiar with the project as they have designed and successfully completed Phases 2 and 3. Jacobs' proposal for the work is in the total amount of \$112,000.00 We have a resolution on tonight for award of Phase 4 to Jacobs.
- Pumping Station & Force Main Condition Assessment & Planning Program Phase 2 was recently completed and included multiple repairs to the Matawan Force Main. R3M has submitted a proposal for Phase 3 that includes an evaluation of another pipe segment,

hydraulic evaluation and the implementation of a long term operational and maintenance monitoring program in the amount of \$66,200.00. We have reviewed the proposal and have a resolution on tonight to award this work to R3M.

- Contract 127-O Annual Furnish and Delivery of Hypochlorite 3 bids were received on January 13, 2022 with a low bid from Kuehne Chemical Co., Inc in the amount of \$275,000.00 for a one-year period.
- Contract 132-O Annual Furnish and Delivery of Caustic Soda 2 bids were received on January 13, 2022 with a low bid from Kuehne Chemical Co., Inc in the amount of \$42,000.00 for a one-year period.
- Contract 133-O Annual Furnish and Delivery of Bioxide 1 bid was received on January 13, 2022 with a low bid from Evoqua Water Technologies, LLC in the amount of \$16,500.00 for a one-year period.
- Contract 134-O Annual Furnish and Delivery of Liquid Polymer The Contract will expire in March. We plan on advertising the new Contract in January and to receive bids in February. There is a resolution on tonight for advertisement of the Contract.
- There are multiple annual operating RFQs for generator inspection and service, Jet/Vac service, Roof inspection and repair and HVAC inspection and repair that we are preparing. Each RFQ will be bid in February. There are resolutions on the agenda tonight to authorize advertisement of each RFQ.

3. Consulting Engineer – R3M

- Power Resiliency System I-Bank is reviewing the drawings and we are waiting on their comments.
- Fuel Oil Tank No. 3 the project is complete.
- WPCP Miscellaneous Structural Repairs We are preparing the final design documents for public bids.
- WPCP Site Specific Odor Control Study Update We have completed task 2a, Air Flow Testing and are currently starting task 2b, an evaluation of odor control upgrades.
- Administration Building Roof Replacement We are meeting to review additional design requirements.
- West Keansburg Pump Station Bypass and Meter Facility Construction Services We continue to review submittals from the contractor. The contractor temporarily demobilized from the site on January 12, 2022. We have provided part time field inspections of construction upon request by the BRSA's project manager.
- Engineering Design Services for West Keansburg Force Main Replacement We performed topographic survey and wetlands evaluation in the field and are beginning preliminary design.
- General Consulting Engineering Services We participated with the BRSA's staff in reviewing the two engineering services proposals for Interceptor Sewer Rehabilitation Phase 4 project.

4. Director of Operations Report

- Plant Performance- 20 million gallons less then November.
- Effluent Quality- is half the permitted limit due to flow split issue which has since been resolved as a result the effluent quality is starting to rebound

- Odor Complaint- we received no odor complaints for this month
- Operations- Operation of the Niro Incinerator continued through December with no scheduled or unscheduled shutdowns.
- Compliance, Safety, and Training-IFCO provided the annual Niro Incinerator training for our Operations staff which is required by our title V permit.
- Industrial Pretreatment Program- The, Regulatory Compliance Manager and Director of Operations attended parts 2 and 3 of the EPA Region 2 Local Limits training Webinar.
- Computers, Instrumentation, and Network Administration- We successfully installed barcode reader functionality to MP2. We have also expanded our purchase order tool to facilitate uploads for integration with QuickBooks
- Treatment Plant- We developed an Ash leak on the inside of the Incinerator that has since been repaired to withstand the harsh environment. The recirculation pump for odor control has failed and since been repaired. We had representatives from Schwing and Ashbrook come to the Authority. They repaired a few minor things as well as did some training.
- Roy Anderson, Superintendent, stated Ashbrook came back out a second time to optimize performance
