A Golden Celebration

The Bayshore Regional Sewerage Authority ("BRSA" or "Authority") recently marked 50 years of essential service to Northern Monmouth County. To celebrate this auspicious milestone, an event was held at The Renaissance in Ocean Township on April 26, 2024. Past and present Authority employees, former and current Authority Commissioners, professionals, and consultants of the Authority were in attendance, along with a number of local elected officials. Among them were New Jersey State Senator Declan O'Scanlon (District 13) and Assemblywoman Victoria Flynn (District 13), who spoke eloquently about the Authority's contributions to the community and presented a Proclamation in recognition of its 50th anniversary.

BRSA was formed in the 1960s, when wastewater treatment was regionalized in Monmouth County. Finding an appropriate location and constructing a wastewater treatment plant took some time. As of February 6, 1974, the Authority was finally, officially in service. The Authority's Board of Commissioners and Executive Director Peter J. Canal felt that a celebration of the Authority's achievements over the last 50 years was well-deserved. As the cocktail hour drew to a close, BRSA Operator Harry Ladisheff stepped up to the podium to perform an invocation. He then passed the microphone to Executive Director Peter J. Canal, who welcomed everyone to the celebration and spoke briefly about the significance of the Authority's 50th anniversary before introducing the event's official moderator, BRSA Assistant Superintendent Charles "Chuck" Theodora.

Those individuals were present to receive framed copies of the signed Resolution, handed to them one by one by Commissioner Mioduszewski. Commissioners McMullen, Lauro, and Whalen each read a Resolution recognizing Roy Anderson, Susan DuBey and Robert Fischer, now all retired from the Authority, who had had a lasting impact on its culture and a hand in its success. A professional photographer captured some of the event's most important moments—including group photos of past and present Commissioners and Authority employees.

Many guests agreed that one of the highlights of the evening came toward the end, when special guest Joseph Anthony performed his standup comedy routine for the crowd. His act touched on a variety of topics, though of course he could not resist lightly roasting Authority management and the wastewater industry itself. The committee tasked with planning the Anniversary event included two members—Harry Ladisheff and Marilyn Raymundo—who went above and beyond by creating a commemorative booklet for all of the attendees to take home with them.
